

UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT
(“Undertaking”)

of

DR. SHEAN SATGUNAM
(“Dr. Satgunam”)

to

COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the “College”)

A. PREAMBLE

(1) In this Undertaking:

“Discipline Committee” means the Discipline Committee of the College;

“OHIP” means the Ontario Health Insurance Plan;

“Public Register” means the College’s register that is available to the public.

(2) I, **Dr. Satgunam**, certificate of registration number **86031**, am a member of the College.

(3) I, **Dr. Satgunam**, acknowledge that the College referred allegations of professional misconduct to the Discipline Committee in a Notice of Hearing dated June 15, 2018 (the “Notice of Hearing”). The College alleged that I engaged in disgraceful, dishonourable or unprofessional conduct under paragraph 1(1)33 of Ontario Regulation 856/93 made under the *Medicine Act*, 1991 (attached at Appendix “A”) by failing to provide complete and/or accurate information to the College and/or hospitals, including in my application to the College for a certificate of registration and in hospital applications for appointments.

(4) Dr. Satgunam denies the allegations and makes no admissions of professional misconduct.

(5) I, **Dr. Satgunam**, acknowledge that, after the College receives an original copy of this Undertaking as signed by me, the College will withdraw the Notice of Hearing.

B. UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT

(6) I, **Dr. Satgunam**, hereby resign from the College effective immediately (the “Effective Date”).

- (7) I, **Dr. Satgunam**, hereby undertake not to apply or re-apply for registration as a physician to practise medicine in Ontario after the Effective Date, for a minimum period of two (2) years.
- (8) I, **Dr. Satgunam**, acknowledge that notwithstanding that the College is withdrawing the Notice of Hearing, information currently in possession of the College may be used by the Registration Committee in consideration of any future application for registration.
- (9) I, **Dr. Satgunam**, acknowledge that in the event that the College should become aware that I am in breach of this Undertaking including, but not limited to, becoming aware that I have either applied, re-applied or attempted to apply or re-apply for registration as a physician or for a certificate of registration to practise medicine in Ontario within two (2) years after the Effective Date, the College shall, in its sole discretion, have the right to proceed with the specified allegations set out in the Notice of Hearing identified in subparagraph (3).
- (10) I, **Dr. Satgunam**, hereby agree to bear the risks relating to the impact on my ability to make full answer and defence of any delay following the execution of this undertaking, and waive the right to seek any remedy on the basis of the passage of time following the execution of this undertaking should I apply for a certificate of registration in the future, or should the College proceed with any allegations pursuant to section (9) above.
- (11) I, **Dr. Satgunam**, undertake to abide by the College's Policy on [Closing a Medical Practice](#).
- (12) I, **Dr. Satgunam**, undertake that upon signing this Undertaking, I shall forward a request to the General Manager of the OHIP that my billing number be deactivated for services rendered after the Effective Date.
- (13) I, **Dr. Satgunam**, acknowledge that all appendices attached to or referred to in this Undertaking form part of this Undertaking.
- (14) I, **Dr. Satgunam**, acknowledge and undertake that I shall be solely responsible for payment of all fees, costs, charges, expenses, etc., if any, arising from the implementation of any of the provisions of this Undertaking.
- (15) I, **Dr. Satgunam**, acknowledge and confirm that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so.
- (16) I, **Dr. Satgunam**, give my irrevocable consent to the College to make appropriate enquiries of OHIP and/or any person who or institution that may have relevant information, in order for the College to monitor my compliance with the provisions of this Undertaking.

(17) I, **Dr. Satgunam**, acknowledge that I have executed the OHIP consent form, attached hereto as Appendix “B” and that the consent forms part of this Undertaking.

(18) ***Public Register***

- (a) I, **Dr. Satgunam**, consent to this Undertaking being posted on the Public Register.
- (b) I, **Dr. Satgunam**, acknowledge that, in addition to this Undertaking being posted in accordance with section (18)(a) above, the following summary shall be posted on the Public Register during the time period that this Undertaking remains in effect:

Allegations of professional misconduct against Dr. Satgunam, including that he failed to provide complete and accurate information in his application to the College and in his applications for privileges at Ontario hospitals, were referred to the Discipline Committee. Dr. Satgunam denies the allegations and makes no admission of professional misconduct. Dr. Satgunam resigned from the College and has agreed not to apply or reapply for registration as a physician in Ontario for a minimum period of two (2) years.
