

**UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT**  
**(“Undertaking”)**

**of**

**DR. INGE VASOVICH**  
**(“Dr. Vasovich”)**

**to**

**COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO**  
**(the “College”)**

**A. PREAMBLE**

(1) In this Undertaking:

“Discipline Committee” means the Discipline Committee of the College;

“OHIP” means the Ontario Health Insurance Plan.

(2) I, **Dr. Vasovich**, certificate of registration number **23797**, am a member of the College.

(3) I, **Dr. Vasovich**, acknowledge that I signed a previous Undertaking to the College on May 11, 2015 (the “Previous Undertaking”) and that the College is monitoring my compliance with the Previous Undertaking in File Number 303704.

(4) I, **Dr. Vasovich**, acknowledge that the College is also monitoring my compliance with an Order of the Discipline Committee dated June 30, 2015 in File Number 312789.

(5) I, **Dr. Vasovich**, acknowledge that the College initiated an investigation bearing File Number 7215252 (the “Investigation”) into whether I engaged in professional misconduct and/or am incompetent in my family medicine practice, and into my compliance with the Previous Undertaking.

- (6) I, **Dr. Vasovich**, acknowledge that there has been no referral to the Discipline Committee in respect of the Investigation and that, if an original copy of this Undertaking as signed by me is delivered to and accepted by the Inquiries, Complaints and Reports Committee, no further action will be taken on the Investigation and on the compliance matters bearing File Numbers 303704 and 312789, respectively.
- (7) I, **Dr. Vasovich**, acknowledge that, if an original copy of this Undertaking as signed by me is delivered to and accepted by the Inquiries, Complaints and Reports Committee, this Undertaking will supersede my Previous Undertaking.

**B. UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT**

- (8) I, **Dr. Vasovich**, hereby resign from the College effective September 30, 2016 (the “Effective Date”).
- (9) I, **Dr. Vasovich**, hereby undertake not to apply or re-apply for registration as a physician to practise medicine in Ontario or any other jurisdiction after the Effective Date.
- (10) I, **Dr. Vasovich**, agree that in the event that the College should become aware that I am in breach of this Undertaking including, but not limited to, becoming aware that I have either applied, re-applied or attempted to apply or re-apply for registration as a physician or for a certificate of registration, or equivalent, to practise medicine in any jurisdiction after the Effective Date, the College shall, in its sole discretion, have the right to proceed with a disciplinary proceeding on the basis of a breach of this Undertaking and shall have the right to proceed with the Investigation it terminated as a result of this Undertaking and/or to proceed with a referral of specified allegations to the Discipline Committee.
- (11) I, **Dr. Vasovich**, hereby agree to bear the risk of any prejudice that the passage of time might cause to my ability to make full answer and defence, and waive the right to seek any remedy on the basis of the passage of time, should the College proceed with any allegations that may arise as a result of a breach of this Undertaking and/or pursuant to section (10) above.

- (12) I, **Dr. Vasovich**, undertake to abide by the College's Policy on Practice Management Considerations for Physicians Who Cease to Practise, Take an Extended Leave of Absence or Close Their Practice Due to Relocation, a copy of which is attached hereto as Appendix "A".
- (13) I, **Dr. Vasovich**, undertake that upon signing this Undertaking, I shall forward a request to the General Manager of OHIP that my billing number be deactivated for services rendered after the Effective Date.
- (14) I, **Dr. Vasovich**, acknowledge that all appendices attached to or referred to in this Undertaking form part of this Undertaking.
- (15) I, **Dr. Vasovich**, acknowledge that I shall be solely responsible for payment of all fees, costs, charges, expenses, etc., if any, arising from the implementation of any of the provisions of this Undertaking.
- (16) I, **Dr. Vasovich**, acknowledge and confirm that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so.
- (17) I, **Dr. Vasovich**, give my irrevocable consent to the College to make appropriate enquiries of OHIP and/or any person who or institution that may have relevant information, in order for the College to monitor my compliance with the provisions of this Undertaking.
- (18) I, **Dr. Vasovich**, consent to and acknowledge that, if this Undertaking is accepted by the Inquiries, Complaints, and Reports Committee, this Undertaking will be entered on the public register as information that is available to the public, commencing on the Effective Date.

- (19) I, **Dr. Vasovich**, acknowledge that, if this Undertaking is accepted by the Inquiries, Complaints, and Reports Committee, the following summary will appear on the College's Register that is available to the public, during the time period that this Undertaking remains in effect:

Dr. Vasovich was the subject of a College investigation into whether she failed to maintain the standard of practice of the profession and/or was incompetent. In the face of this investigation, Dr. Vasovich voluntarily resigned from the College and has agreed never to apply or reapply for registration as a physician in Ontario or any other jurisdiction.
