Conditions:

YOU MUST OBEY ALL OF THE CONDITIONS LISTED BELOW:

1. Keep the peace and be of good behaviour.
2. Appear before the court when required to do so.
3. Report as the Court directs in person to a supervisor and thereafter report when required by the supervisor and in a manner directed by the supervisor.
4. Remain in Ontario unless you have prior written permission from the Court or the supervisor to leave the province.
5. Notify the court or supervisor in advance of any change of name or address and promptly notify the court or supervisor of any change in employment or occupation.
6. Report in person to a supervisor within 2 (two) working days and after that, at all times and places as directed by the supervisor or any person authorized by a supervisor to assist in your supervision.
7. Reside at [redacted], and keep your Conditional Sentence Supervisor advised of any change in your address.
8. The home confinement condition will be in effect for the first 3 months of the sentence.
9. For the first three months of this order, remain in your residence or on the property of your residence at all times

EXCEPT

- between 5:00 p.m. and 9:00 p.m. on Saturdays in order to acquire the necessities of life;
- for any medical emergencies involving you or your child or spouse;
- for employment purposes and travelling to and from the workplace or institution via a direct route;
- to attend medical appointments for you or your child and traveling to and from the hospital or clinic by direct route;
- while travelling to and from via a direct route and while attending court at a scheduled court appearance or under subpoena or while at counsel's office or the College of Physicians and Surgeons;
- otherwise with the permission of your Conditional Sentence Supervisor;
- while attending a regularly-scheduled religious service once per week with advance permission of your supervisor.

10. For the remaining three months (months 4, 5, and 6) of this Order, remain in your residence or on the property of your residence at all times daily between the hours of 11:00 p.m. and 6:00 a.m.

EXCEPT

- for any medical emergency involving you or your child or spouse;
- travelling directly to, from and while at your place of employment, if required.

11. For the entire six months of this order, do not contact or communicate in any way, either directly or indirectly, by any physical, electronic or other means, with: [redacted].

12. During the entire 6 months of this Order, continue counselling with [redacted] (or replacement) as directed by your Conditional Sentence Supervisor.
13. During the entire 6 months of this Order, you are not to possess any handheld device with recording capabilities.
14. During the entire 6 months of this Order, you must present yourself at the entrance of your residence within five minutes of a door knock should a peace officer or your Conditional Sentence Supervisor attend to check on your compliance with your house arrest/curfew conditions.


Variation:

At any time, you, the prosecutor, or the supervisor can apply to the court to vary any of the additional conditions.

Be warned that refusal or failure, without reasonable excuse, to comply with any condition of this Order may result in arrest or imprisonment for the remainder of your sentence. The Court may also change or suspend the conditions of your order.
