

UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT
(“Undertaking”)

of

DR. WAYNE EDGAR STANLEY
(“Dr. Stanley”)

to

COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the “College”)

A. PREAMBLE

- (1) In this Undertaking:

“Discipline Committee” means the Discipline Committee of the College;

“OHIP” means the Ontario Health Insurance Plan.

- (2) I, **Dr. Stanley**, certificate of registration number 85675, was a member of the College from October 6, 2006 to August 21, 2015, when my certificate of registration was ordered revoked by the Discipline Committee (“Revocation of my Certificate of Registration”).
- (3) I, **Dr. Stanley**, acknowledge that I have not practiced medicine in Ontario since August 21, 2015.
- (4) I, **Dr. Stanley**, acknowledge that, following an investigation into allegations separate from those that led to the Revocation of my Certificate of Registration, the College referred allegations to the Discipline Committee in a Notice of Hearing dated June 15, 2016 (the “Notice of Hearing”), attached as Schedule “A” to this undertaking, that I:
- a. engaged in sexual abuse of two patients; and
 - b. engaged in conduct or an act or omission relevant to the practice of medicine that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional.
- (5) I, **Dr. Stanley**, acknowledge that, after the College receives an original copy of this Undertaking as signed by me, the Notice of Hearing dated June 15, 2016, will be withdrawn.

- (6) I, **Dr. Stanley**, warrant that I have not applied or re-applied for registration as a physician to practise medicine in Ontario or any other jurisdiction after the Revocation of my Certificate of Registration.

B. UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT

- (7) I, **Dr. Stanley**, hereby undertake not to apply or re-apply for registration as a physician to practise medicine in Ontario, or any other jurisdiction, as of the date I sign this undertaking (the “Effective Date”).
- (8) I, **Dr. Stanley**, agree that, in the event that the College should become aware that I am in breach of this Undertaking, including, but not limited to, becoming aware that I have either applied, re-applied or attempted to apply or re-apply for registration as a physician or for a certificate of registration, or equivalent, to practise medicine in any jurisdiction after the Effective Date, the College shall, in its sole discretion, have the right to proceed with a disciplinary hearing on the basis of a breach of this Undertaking and shall have the right to proceed with the specified allegations set out in the Notice of Hearing dated June 15, 2016 (Appendix A).
- (9) I, **Dr. Stanley**, hereby agree to bear the risk of any prejudice that the passage of time might cause to my ability to make full answer and defence, and waive the right to seek any remedy on the basis of the passage of time, should the College proceed with any allegations that may arise as a result of a breach of this Undertaking and/or pursuant to paragraph (8) above.
- (10) I, **Dr. Stanley**, undertake that upon signing this Undertaking, I shall forward a request to the General Manager of OHIP that my billing number be deactivated for services rendered after the Effective Date, and shall provide proof to the College of my request within ten (10) days of the date it was sent.
- (11) I, **Dr. Stanley**, acknowledge that I shall be solely responsible for payment of all fees, costs, charges, expenses, etc., if any, arising from the implementation of any of the provisions of this Undertaking.
- (12) I, **Dr. Stanley**, acknowledge and confirm that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so.
- (13) I, **Dr. Stanley**, give my irrevocable consent to the College to make appropriate enquiries of OHIP and/or any person who or institution that may have relevant information, in order for the College to monitor my compliance with the provisions of this Undertaking.

- (14) I, **Dr. Stanley**, consent to this Undertaking being entered on the public register as information that is available to the public.
- (15) I, **Dr. Stanley**, acknowledge that the following summary will appear on the College's Register that is available to the public during the time period that this Undertaking remains in effect:

Dr. Stanley's Certificate of Registration was revoked by Order of the Discipline Committee on August 21, 2015. Dr. Stanley was the subject of an additional referral to the Discipline Committee on allegations that he engaged in sexual abuse of two patients and that he has engaged in conduct or an act or omission relevant to the practice of medicine that, having regard to all the circumstances, would reasonably be regarded by members as disgraceful, dishonourable or unprofessional.

On the basis that Dr. Stanley has agreed never to apply or reapply for registration as a physician in Ontario or any other jurisdiction, the College has withdrawn the additional referral to the Discipline Committee.
