

UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT
(“Undertaking”)

of

DR. FAROOQ ALI KHAN
(“Dr. Khan”)

to

COLLEGE OF PHYSICIANS AND SURGEONS OF ONTARIO
(the “College”)

PREAMBLE

In this Undertaking:

“Discipline Committee” means the Discipline Committee of the College;

“OHIP” means the Ontario Health Insurance Plan;

“Public Register” means the College’s register that is available to the public.

I, **Dr. Khan**, certificate of registration number 104204, was a member of the College from June 20, 2014 until I resigned from the College on February 22, 2021.

I, **Dr. Khan**, acknowledge that on April 10, 2018, the Discipline Committee made a finding of professional misconduct and on May 29, 2020, the Discipline Committee released its decision regarding penalty.

I, **Dr. Khan**, further acknowledge that on June 23, 2020, the College commenced an appeal of the Discipline Committee’s penalty decision in the Divisional Court.

I, **Dr. Khan**, acknowledge that, after the College receives an original copy of this Undertaking as signed by me, the College will abandon its appeal without costs.

UNDERTAKING, ACKNOWLEDGEMENT AND CONSENT

I, **Dr. Khan**, acknowledge that I resigned from the College on February 22, 2021.

I, **Dr. Khan**, hereby undertake not to apply or re-apply for registration as a physician to practise medicine in Ontario, effective immediately. (“Effective Date”).

I, **Dr. Khan**, undertake to abide by the College’s Policy on [Closing a Medical Practice](#).

- I, **Dr. Khan**, undertake that upon signing this Undertaking, I shall forward a request to the General Manager of the OHIP that my billing number be deactivated for services rendered after the Effective Date.
- I, **Dr. Khan**, acknowledge that all appendices attached to or referred to in this Undertaking form part of this Undertaking.
- I, **Dr. Khan**, acknowledge and undertake that I shall be solely responsible for payment of all fees, costs, charges, expenses, etc., if any, arising from the implementation of any of the provisions of this Undertaking.
- I, **Dr. Khan**, acknowledge and confirm that I have read and understand the provisions of this Undertaking and that I have obtained independent legal counsel in reviewing and executing this Undertaking, or have waived my right to do so.
- I, **Dr. Khan**, give my irrevocable consent to the College to make appropriate enquiries of OHIP and/or any person who or institution that may have relevant information, in order for the College to monitor my compliance with the provisions of this Undertaking.
- I, **Dr. Khan**, acknowledge that I have executed the OHIP consent form, attached hereto as Appendix “A” and that the consent forms part of this Undertaking.

Public Register

- (a) I, **Dr. Khan**, consent to this Undertaking being posted on the Public Register.
- (b) I, **Dr. Khan**, acknowledge that, in addition to this Undertaking being posted in accordance with section (15)(a) above, the following summary shall be posted on the Public Register during the time period that this Undertaking remains in effect:

On May 29, 2020, after having found Dr. Khan engaged in professional misconduct, the Discipline Committee of the College released reasons on penalty. The College commenced an appeal of the Discipline Committee’s penalty decision. Dr. Khan resigned from the College and has agreed never to apply or reapply for registration as a physician in Ontario.
